Dissertation: *Peace Agreements as Counterinsurgency* examines how, in multi-party civil wars, governments use peace agreements with a subset of rebel groups as a counterinsurgency tool to counter rebel groups that remain outside the peace agreement. The dissertation also examines how the dynamics of multi-party conflicts affect the bargaining power of insurgents in negotiations with the government, as well as the use of former rebel soldiers in counterinsurgency offensives.
